## Séché Environnement in charge of the evacuation and treatment of residues from the fire at the Bolloré Logistics warehouse site in Grand-Couronne (Seine-Maritime)

Séché Urgences Interventions (SUI), a subsidiary of Séché Environnement specialising in emergency response, is involved in the management of residues from the fire at the Bolloré Logistics site in Grand-Couronne, Seine-Maritime. The fire, which occurred in January 2023, destroyed part of the warehouse where 12,000 lithium batteries were stored. From 3 to 12 March, SUI proceeded with the installation of the site, on an area of 6,000m<sup>2</sup>. It will continue over a period of 7 to 9 weeks depending on the technical constraints encountered during the treatment of the waste.

Séché Urgences Interventions has deployed a team of 12 highly qualified people to secure the residues of the fire and has the means to guarantee the safety of the site's operations. All the waste will be taken care of and sent to treatment centres of Tredi, a subsidiary of Séché Environnement. The waste will be subjected to thermal treatment and energy recovery.

Thus, Séché Urgences Interventions uses its know-how and logistical capacities to guarantee optimal and safe waste management as part of this intervention, contributing both to the decontamination of the site and to the



protection of the environment. This action is part of the company's overall response to industrial crisis situations, in particular the risks associated with hazardous materials such as lithium batteries.
